Councillor Clark requested that Item 7.1 be tabled to the February 14, 2007 meeting of Council:

**7.1 Moratorium on the Construction of any New Nuclear Power Plants within the Municipal Boundaries of the City Of Hamilton**

**WHEREAS** the Government of Ontario has indicated that the demand for electricity will continue to rise resulting in a need for an additional 15,700 megawatts by 2025.

**WHEREAS** the Government of Ontario has indicated that the expansion of the Nuclear power generation plants will be required to meet the growing demands for electricity.

**WHEREAS** an established Hamilton company has suggested that some of their land, in Nanticoke, could be used for the construction of a new Nuclear Power Generation Plant.

**WHEREAS** the Haldimand County Mayor has indicated that any bid to build a nuclear power plant should be put to the people.

**WHEREAS** the following groups have publicly indicated their opposition to the construction of any new Nuclear Power Plants: Campaign for Nuclear Phase-out, Canadian Environmental Law Association, Concerned Citizens of Renfrew County and Area, David Suzuki Foundation, Ecology North, Greenpeace Canada, Humber Environment Action Group, Inter-Church Uranium Committee Educational Cooperative, Mouvement Vert de la Mauricie, Nuclear Awareness Project, Pembina Institute for Appropriate Development, Science for Peace, and Sierra Club of Canada.

**WHEREAS** Germany and Belgium recently legislated the phasing out of their nuclear reactors, in favour of green energy options and energy efficiency.

**WHEREAS** an April 2006 report released by Greenpeace predicted more than 270,000 cancers will be caused by radioactive fallout from Chernobyl, and of these, 93,000 will be fatal.

**WHEREAS** the Sierra Club of Canada advocates a sensible mix of solutions, involving the highest possible level of energy efficiency by North American households and businesses alike, the deployment of renewable sources such as wind and solar power, and a widespread shift to new, innovative technologies like hybrid and fuel cells to move people and goods around.

**THEREFORE BE IT RESOLVED THAT:**

- (a) The City of Hamilton implements a moratorium on the construction of any new Nuclear Power Plants within the municipal boundaries of the City Of Hamilton.
- (b) The City Of Hamilton informs Haldimand County about Hamilton's concerns and objections to the potential construction of a Nuclear Power Plant within Hamilton's air-shed.
- (c) The City of Hamilton informs the Government of Ontario that the City will oppose the construction of a Nuclear Power Plant within Hamilton's air-shed.

**8.1 Reduction of Parkland Dedication Fees for Non-Profit Housing Seniors Housing – 37 Strathcona Avenue North, Hamilton, Ontario**

**WHEREAS**, the City of Hamilton has a 20% poverty rate, and seniors comprise 17% or 15,745 individuals living in poverty, mainly single women, and;

**WHEREAS**, seniors comprise a significant percentage of renters in Hamilton, and that percentage is forecasted to rise as noted in the City of Hamilton's Keys to the Home report, to over 25% of all renter households by 2031, and;

**WHEREAS**, there is a strong need for seniors non-profit affordable housing in Hamilton, and;

**WHEREAS**, the Hellenic community is one of the first community groups to propose non-profit affordable housing for seniors under the new Canada-Ontario Affordable Housing Program – Strong Start program, and;

**WHEREAS**, the density provisions in Section 3(b) of the Parkland Dedication Bylaw do not differentiate between for-profit and not-for-profit affordable housing, and;

**WHEREAS**, City Council provided relief to the Good Shepherd Society for a similar 20 unit building at 143 Wentworth Street South on July 12, 2006,

**THEREFORE BE IT RESOLVED:**

- (a) That the cash-in-lieu fees payable by the Hellenic Community under the Parkland Dedication Bylaw as per the staff calculation at \$128,968 be reduced by 50% to \$64,484 for their 39 unit seniors non-profit affordable housing development at 37 Strathcona Avenue North, with funding coming from "Unallocated Capital Reserve Account 108035", and
- (b) That staff be asked to review the policy for reduction of parkland dedication fees for non-profit affordable housing.
