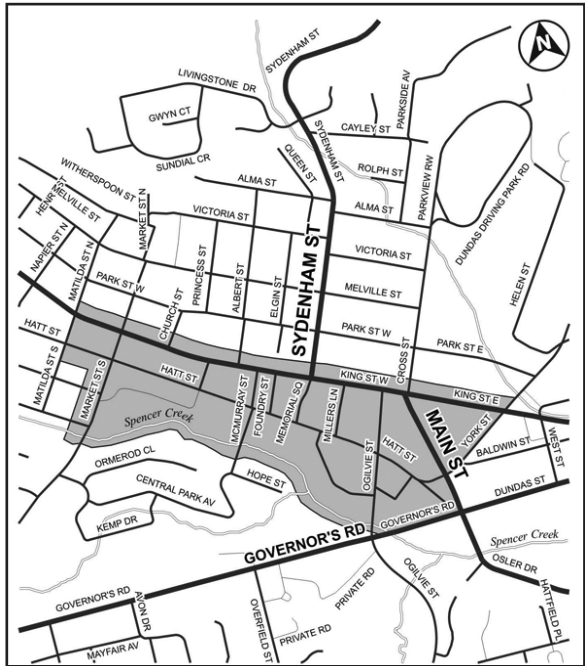


NOTICE OF STUDY COMPLETION & PUBLIC INFORMATION CENTRE FOR DOWNTOWN DUNDAS TRANSPORTATION MASTER PLAN

THE PROJECT AND PROCESS

The City of Hamilton has completed the Downtown Dundas Transportation Master Plan (DDTMP) consistent with the Municipal Engineers Association Municipal Class Environmental Assessment (EA) process (October 2000, as amended in 2007).

Recommendations have been developed for the existing transportation network until the 2031 horizon year. The DDTMP has identified design and implementation recommendations which include: Intersection and Roadway Improvements, Transit Facility Improvements, Cycling Facility Improvements as well as Pedestrian and Trail Facility Improvements.



The Master Plan report presents the analysis and evaluations undertaken to determine the transportation system required to support Downtown Dundas. The City of Hamilton will be holding an additional Public Information Centre to discuss the final recommendations in the Downtown Dundas Transportation Master Plan.
